Unanimous Approval of NYS Independent Redistricting Commission's proposed Assembly District for Richmond Hill, Ozone Park and South Ozone Park Makes Strides in Addressing Community Concerns

With the release of proposed map "AL," attached, the New York State Independent Redistricting Commission demonstrated that they had heard the demands of the community to keep the longstanding, diverse and growing South Asian and Indo-Caribbean community in the neighborhoods of Richmond Hill, Ozone Park and South Ozone Park together.

We thank you for listening, evaluating and doing your job-fairly and equally. We have been denied a seat in government at all levels, and it is time to bring this discrimination and apartheid to a stop. Elected officials ignore us, and pander to others. It is most un-American!

The proposed Assembly map "AL," really reflects the will of the community, and is compact and contiguous, and respects natural boundaries. Moreover, it reflects the large population of first and second generation of minorities and immigrants who have rejuvenated and improved this community here in Richmond Hill, Ozone Park and South Ozone Park.

For the past 30 years, over 3 redistricting cycles, we have been asking to keep our neighborhoods together so we can have a true voice in government, and access resources for our community. However, our pleas were ignored, so this is a landmark development for this community of interests. This is a great map, and we feel that our voices are being heard, as they should.

Another veteran community advocate and labor activist, Real Estate Broker Paul Persaud, of the Guyana American Business Group, has said, "We look forward to engaging this process to implement map AL that really reflect our neighborhood identity. We are grateful that our advocacy was heard at the Assembly level, particularly on behalf of the essential workers who abound in our community here."

Garth Marchant of the South Ozone Park, Richmond Hill and Ozone Park United for Justice and Empowerment organization was also encouraged by the progress made. "We will continue to fight to keep these Assembly lines, to keep these minority communities of color whole."

Mike Persaud, a teacher who has taught children in the district's schools since the 1980s, summed it up succinctly. "Our kids, and succeeding generations, will now get the educational funding they deserve to achieve a better life. Our businesses will get the help they need to survive. Our families will get the medical help they need. We can now achieve and preserve the American Dream in all respects."

Sonny Ali, a restauranteur and businessman who runs a chain of roti shops, was grateful that his community of Richmond Hill, Ozone Park and South Ozone Park is finally being recognized. The City renamed Richmond Hill "Little Guyana" and "Punjab Avenue," and it is only fitting that the State draw us a district we can relate to, continue to build, and prosper. The American dream must be attainable for everyone, and we pay a lot of taxes here, and contribute to the City, State and Federal levels. All we are asking for is to be treated fairly, and equally, with other groups.

The South Queens Redistricting Coalition is a group of community residents, organizers and organizations formed to correct the gerrymandering of the Richmond Hill, Ozone Park and South Ozone Park neighborhoods of Queens. This area is diverse and reflects the full range of the South Asian diaspora as well as a vibrant Latino community. The South Asian community is anchored by significant Indo-Caribbean, Indian, Punjabi and Bengali populations. These communities contribute indelibly to the significant growth of the Asian American population in Queens, NYS and in the broader USA, and stands in unity with the Pan-Asian community in asking for a greater voice in representative government.

Lucia Diaz

Good evening everyone, my name is Lucia Diaz and I am a member of Make The Road NY. I live in Corona, Queens, Assembly District 39. I have been a member of Make The Road for a long time and I am very pleased to see how my assembly member Catalina Cruz works very closely with my organization. It is certain that we have always needed more representation. I'm happy to finally see someone in the Assembly that identifies with me. A hard working woman and of immigrant background and someone who speaks my native language. We need to keep pushing to see more women in power and keep this representation that has not been easy to finally see in our community. The current Assembly map allows us to do that in Western Queens, where we now have six districts represented by six assembly members of color, with three of them being Latino. Your proposed map would undo that progress—by preventing us from electing three Latinos in the area—and it should be rejected. It also does not make sense to have one of the districts connected to Manhattan, which is a very different community and would reduce representation for Queens. I ask you to fix it and go back to the current Assembly map, which has allowed us to make progress for representation in our communities in Western Queens. Thank you.

It also does not make sense to have one of the districts connected to Manhattan, which is a very different community and would reduce representation for Queens. I do not think your proposal for Western Queens is a good one. Instead, I call on you to go back to the district lines passed last year for this region. Thank you.

Ruth Lopez Martinez

Good evening everyone, my name is Ruth Lopez Martinez. I am a longtime resident of Queens and a member of Make The Road NY. I am here today to share that I have been in the process of organizing and helping register, educate, and mobilize members of our communities to participate in the political process. We have worked so hard to get our neighbors involved in the process to be counted and decide who should represent them. And now all of that hard work is being jeopardized with the IRC's proposal for Western Queens. Under the current Assembly map, we were able to see our assembly members get elected by the people of the immigrant and Latino community, three of six districts in our neighborhoods represented by Latinos. Your proposal would likely lead us to lose some of that representation. The Latino population in Queens has increased a lot since the last census. If anything, we should get more representation, not less. Please, I ask that we please keep our current assembly districts for Western Queens. Thank you.

AHADOCATING DE FEED 2022 districts 30,34,35,36,37,39 Thank you for the opportunity to testify regarding the Assembly redistricting maps. My name is Perla Silva and I testify as Make The Road's Civic Engagement Coordinator. MRNY operates community centers in Jackson Heights, Queens; Brentwood, Long Island; Bushwick, Brooklyn; Port Richmond, Staten Island; and White Plains, Westchester. Our 25,000 members build the power of our communities to achieve dignity and justice through organizing, policy innovation, transformative education, and survival services.

We have worked for 25 years to increase the voice of and representation for immigrant communities and communities of color across Queens and other areas of our state. One of the areas where we have done the most work has been in Western Queens. Most of our Queens membership lives in Western Queens.

I am here today to share our community members' concern about the IRC's Assembly map proposal for Western Queens, which we believe will reduce representation for immigrant and Latine communities—and communities of color more broadly—in the region.

I have had the privilege to work very closely with our members to successfully help our communities register, educate, and mobilize other members of our communities to participate in the political process—both in campaigns to win public policies, in the census process (for which we conducted outreach to tens of thousands of Queens residents), and in advance of elections. We have taken major strides forward—following the census and with the current Assembly map passed last year, we are finally in a position where the six primary Assembly districts in the area (30, 34, 35, 36, 37, and 39) are represented by people of color, several of which come from diverse immigrant backgrounds. Of these six, three of them are Latine. This is a huge victory for the members of MRNY as they have participated in helping our communities express their voice and help make this possible.

The IRC proposal would make that level of representation virtually impossible to maintain. We are particularly concerned that the Latine community would lose ground. For the communities we represent, the districts as they are currently constituted would be far better for maintaining the current level of representation, rather than finding it reduced.

It is also nonsensical to include Manhattan in a Queens district (the Long Island City district), effectively reducing the representation in Western Queens.

We therefore urge the IRC to revise the map for Western Queens and revert to the district lines passed last year for this region.

Carmen Garcia

Good evening everyone, my name is Carmen Garcia. I am here to testify as a long-time Queens resident and as a mother of two sons.

I am a Community Health Worker Supervisor in the health department team at Make the Road New York. I have been working with Make The Road for almost 10 years. I am an immigrant from Ecuador and I have been living in Queens, New York for over 20 years.

When my family and I first moved here, we had a hard time finding affordable and dignified housing. My husband, my 5yr old son, and I rented a small room in an apartment that we shared with another family. Every day in my work as a Community Health Worker I met with many families going through this same situation due to the shortage of affordable and safe housing.

Overcoming the language barrier was challenging. This was very important for me because I needed to advocate for my children's education and their health. My team and I work for immigrant communities and communities of color across Queens and we have done most of our work in Western Queens. We know how important it is for people in our community to access many programs and services in their native language.

We as a nonprofit organization know the importance of representation and as we advocate for that representation, we are pleased to work alongside our current assembly members that also come to our organization and support our members. Our current assembly members have been there for the community of MRNY since they took the oath of office.

The new map proposed by IRC would make that virtually impossible to maintain—and the Latino community in particular would lose representation, even though our population has grown in the last decade. It also does not make sense to have one of the districts connected to Manhattan, which is a very different community and would reduce representation for Queens. We, therefore, urge the IRC to revise the map for Western Queens and revert to the district lines passed last year for this region. Thank you for your time.

I'm here to oppose the Independent Redistricting Commission's draft map for Woodside, Jackson Heights, and Elmhurst. This draft map divides the Jackson Heights Business District into two parts. (Agree with Farzana, state here where the Business District is located). Dividing the current business district apart serves no one. Instead, it divides our community apart. We can not accept it. We want to stay in one district so we can go to one office to speak to our representative to speak about our shared small business-related issues. This combined power gives our voices extra weight. In that light, we are currently forming a new merchant association in the district. (If the IRC draft map for AD 30 was adopted, then we would have to form two merchant associations for one business district). (This is ineffective, burdensome, and costly). By a conservative estimate we reach 200,000 residents of South Queens, particularly Richmond Hill and South Ozone Park.

We also reach over 500,000 South Asians in NYC. To name a few of the groups I work with include the Rajkumari Center, AALDEF, Sakhi for South Asian Women, the Indo-Caribbean Alliance, the RHEDC, The American Cancer Society-Eastern Division and National Cancer Action Network, The Asian American/Asian Research Institute of CUNY, the South Asian Journalists Association, South Queens Women's March, Jahajee Sisters, the United Communities Alliance, among many others. Don't take my word for it, reach out to them and they will confirm my many years of continuous service.

Chhaya CDC's Queens Redistricting Hearing Testimony February 16, 2023

Hello, My name is Urgen Sherpa. I am the Senior Small Business Organizer at Chhaya CDC, a member organization of the APA VOICE Redistricting Task Force and I am also a long-time resident and voter in Jackson Heights.

CHHAYA is a 22-year-old community organization, serving South Asian and Indo-Caribbean communities across Queens, including Elmhurst, Woodside, and Jackson Heights.

CHHAYA works to build housing stability, economic well-being, and the power of the community by providing a number of direct services which include tenant counseling and small business support. Over the last two decades, this community has been and continues to be severely underserved while facing some of the hardest housing and economic issues in New York City. This is especially true of small businesses.

While the pandemic exacerbated many of these issues, small business owners have been struggling for some time with unreasonably high rent, little to no commercial tenant rights, and harassment from landlords resulting in many small businesses barely hanging on or being forced to shut down.

In spite of the fact that more than one-third (35.1% as of 2021) of the small businesses in Queens are Asian-owned, Asian small businesses have been left behind when it comes to accessing any government aid and resources often due to the absence of language access and community engagement.

AD30 holds an important South Asian cultural and commercial corridor that has served the South Asian community in Jackson Heights, Woodside, and Elmhurst for decades. It is a critical corridor that is part of the cultural history and fabric of the neighborhood.

The IRC draft currently splits this essential corridor that in reality spans from 72nd street and 76th street which includes 37th avenue, 37th road, and Roosevelt avenue. 35th avenue between 72nd street and 70th Street. But if we are talking about where the vast majority of the small businesses are concentrated, then it is from 72nd street and 75th street which includes 37th avenue, 37th road, and Roosevelt avenue.

Additionally, the Tibetan Library and Cultural Center on 57th Street and 32 not avenue has been left out of AD30 in the IRC draft when it is a critical cultural institution and serves many in Jackson Heights, Woodside, and Elmhurst. We urge the commission to adopt the proposed map by APA Voice Redistricting Task Force to ensure that South Asian small businesses and cultural institutions in Jackson Heights are not fractured and are kept whole with the rest of the Asian communities in Jackson Heights, Elmhurst, and Woodside. Please give us an opportunity to gain representation and the ability to collectively advocate for ourselves.
